The VNA Foundation designed our Spring 2026 Grants to be used flexibly within the greater North Penn region as defined on our website.

IMPORTANT NOTE:

The Spring 2026 process differs greatly depending on whether your organization was a recipient of a Spring 2025 grant from the VNA Foundation. Please read below for details.

FOR RECIPIENTS OF SPRING 2025 GRANTS: For recipients of VNA Foundation's Spring 2025 grants only, **the final report and 2026 application process will take place as a Zoom conversation** with VNA Foundation staff and Board members, instead of as a written application. VNA Foundation staff will transfer certain responses from each grantee's Spring 2025 application into the 2026 form and request that applicants provide verbal updates during our conversation. VNA Foundation staff will complete the 2026 application forms in our online system, eliminating the need for our recent grant partners to submit a written application for this cycle.

FOR OTHER INTERESTED APPLICANTS: If your organization was NOT a recipient of a VNA Foundation Spring 2025 grant and wishes to apply for a Spring 2026 grant, please DO NOT submit a written application in our online system, but instead begin the process by sending an email by 5 PM on February 13, 2026 to Diana Doherty at ddoherty@npvnafoundation.org with the subject heading "Spring 2026 Grant Inquiry" and containing the following information:

Please do not send additional information or attachments in this email inquiry. For those inquiries submitted via email before the due-date, VNA Foundation staff will respond within approximately 48 hours of the submission and communicate with you to determine whether you should submit a formal application in our online system. Email inquiries sent after 5 PM on February 13th, 2026 will not be considered for the Spring 2026 grant cycle.

TYPES OF FUNDING:

All Spring 2026 grants are for organizations that directly provide under-resourced people with access to **Food, Housing, and Basic Health needs (including mental health & addiction)**. **All applicants must hold IRS-nonprofit status.**

Spring 2026 grants will be available in two forms (max \$20,000 for one year for either type):

GENERAL OPERATING: For those organizations whose total service population is MAJORITY greater North Penn; **OR**

FLEXIBLE PROGRAM: For those organizations whose total service population is not predominantly greater North Penn, but who offer one or more program(s) to greater North Penn residents. Funding can be applied to multiple programs.
